No purchase, obligation or bank service necessary. All entries have an equal chance of winning.

1. **How to Enter:** The contest starts at 12:01am (ET) on July 1, 2019, and ends at 11:59pm (ET) on July 31, 2019. You will automatically receive one (1) entry in the \$250 Summer Cash Giveaway for 20 or more JBT Discover® Debit Card credit transactions (non-PIN signature based transactions) completed in the month of July 2019. Pending transactions are not eligible. Transactions that are returned will not be included in the total count needed to qualify for automatic entry. You must use your JBT Discover® Debit Card. Only non-PIN purchases run as a credit signature based transaction qualifies.
To enter without purchase, obligation or bank service, hand-print your name, address, city, state, zip code, phone number and words “\$250 Summer Cash Giveaway” on a 3” X 5” card, and mail in a stamped #10 envelope, hand printed to: JBT ELECTRONIC BANKING DEPARTMENT, Attn: \$250 Summer Cash Giveaway Prize Drawing, PO Box 717, Jonestown, PA 17038 (“Mail-in Entry”).
