1. How to Enter: The contest starts at 12:01am (ET) on January 1, 2026, and ends at 11:59pm (ET) on February 28, 2026. Enter the Drawing by returning your entry blank via mail or in person to the JBT branch of your choice. Hand the entry to a branch associate or place it in the Birthday Decorated entry box available in the lobby at any JBT branch.

You can also enter by hand-printing your name, parent/guardian's name, address, city, state, zip code, phone number, birthdate and words "Young Investors Savings Club Monthly Birthday Prize Drawing" on a 3" x 5" card, and mail in a stamped #10 envelope, hand printed to: Jonestown Bank & Trust Co., Attn: Young Investors Savings Club Monthly Birthday Prize Drawing, 100 North Harris Street, Suite B, Cleona, PA 17042. Only one entry per person allowed, regardless of entry method. All entries must be received by February 28, 2026 to be eligible.
