1. **How to Enter:** The contest starts at 12:01am (ET) on September 20, 2021 and ends at 1:00pm (ET) on October 2, 2021. Enter the Drawing by returning your entry blank via mail or in person to the Ephrata JBT branch located at 1001 Sharp Avenue, Ephrata, PA 17522.
To enter without purchase, obligation or bank service, fill out an entry form at any JBT branch location and hand the entry to a community banker. Or hand-print your name, address, city, state, zip code, phone number and words "Ephrata 10th Anniversary Celebration Prize Drawing" on a 3" X 5" card, and mail in a stamped #10 envelope, hand printed to: Jonestown Bank & Trust Co., Attn: Ephrata 10th Anniversary Celebration Prize Drawing, 1001 Sharp Avenue, Ephrata, PA 17522. Regardless of the method of entry, only one entry per household. All entries must be received by October 2, 2021 to be eligible.
